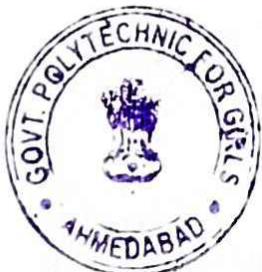


**In particular, this MOU is intended to**

- Arrange the placement for participated trained students


The validity of the agreement of Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of termination, both parties have to discharge their obligations.

Any disputes are subject to Ahmadabad Jurisdiction only.






